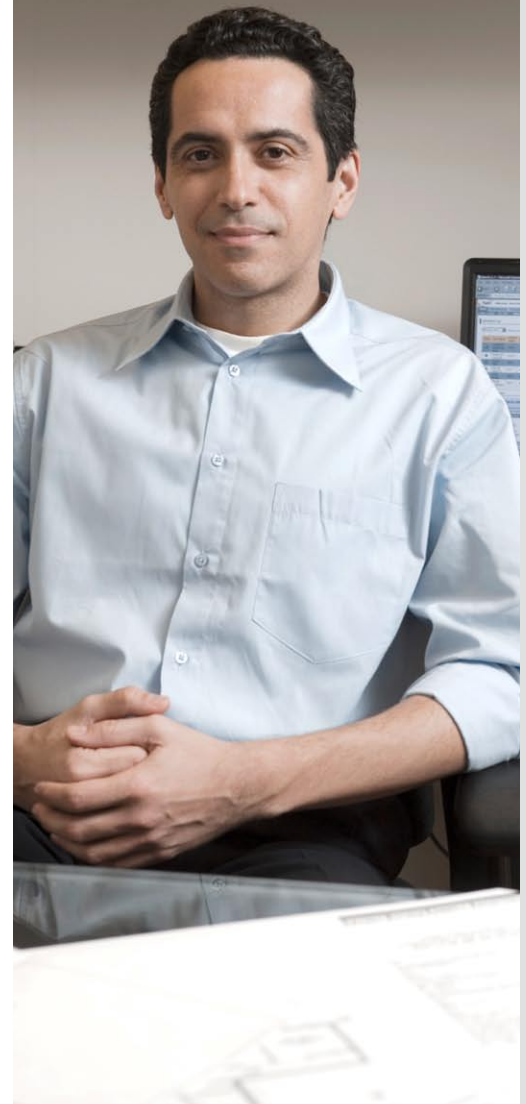
gram monitoring, execution, and reporting responsibilities, they must be able to break free from their traditionally siloed operations and develop new communication and collaboration capabilities.
